#### **PAYMENT DEFAULT**

Non-payment of installment without prior notice (written via email) will attract 10% of the expected amount, and where such payment is defaulted 3 consecutive months, it will be considered a breach of contract and the company has the right to terminate such contract and make refund on the amount paid less 25% (20% Administrative and 5% default fees)
